VII. PUBLIC HEARINGS

Mark Glisson & Nicky Powell – Public Hearing (1): The applicant request to rezone 34.67 acres **Map# 391 Parcel# 19** from **R-1** to **R-1** with the removal of a stipulation (Fourth District).

Mr. Mark Glisson and Mr. Nicky Powell requested the board remove the stipulation of an accel/decel lane previously approved by the Board of Commissioners for their development. Mr. Glisson stated the development was built according to the construction drawings.

There was a quick discussion about curbing and speed limit in that area.

No one was present in favor or against the request.

Tim Uzupan made a motion to deny the request. Jeff Wilkes seconded the motion. The motion carried unanimously.

Effingham County – Public Hearing (2): The applicant request to amend **Appendix C – Zoning Ordinance, Section 2.55.1, 2.55.2 and 5.4.1.2** of the Code of Effingham County.

Mr. George Shaw stated the amendment to the ordinance will allow for conformity in the Meldrim area in regards to setbacks. Mr. George Shaw stated a couple of community meetings to discuss options have been held. Mr. Shaw referred to a map which showed options for reduced setbacks. Mr. Shaw confirmed the zoning would remain the same and the proposal does not apply to properties where duplexes are constructed.

Ms. Linda Lattke questioned the affect for existing homes. Mr. George Shaw stated there would be no affect, property owners would be allowed to expand into the expandable areas.

Jeff Wilkes made a motion to approve the request. Jasper Lee seconded the motion. The motion carried unanimously.
