Terms: Owners of real property on which a dwelling unit or business is erected after the beginning of a given budget year shall be subject to a pro-rated *special tax assessment* that equals the pro-rated amount of the annual *assessment* calculated from the beginning of the month in which service is requested plus a ten (10) percent administrative charge. Owners of real property on which a dwelling unit or business unit is erected after the beginning of a budget year shall not be required to pay the *special tax assessment* for the then current budget year; however, the County shall not provide solid waste collection service to such property unless and until an application for service and the pro-rated *assessment* are received.

Sanitation charges are billed through the property tax bill once the initial service is set up. Charges are added to the tax billing process through May of each calendar year.

Once the tax billing process has been closed for the tax bill year an individual applying for service pays for the current months remaining in the calendar year and the next full year.

If Sanitation charges have not been previously setup for the parcel of property then the clerk taking the payment and instituting service will bill for the current and next year's service

Sanitation charges will be charged on your current year property tax bill for the following year's sanitation service and each year thereafter.
